

OFFICIAL RULES

Void where prohibited by law.

1. How to Enter. NO PURCHASE NECESSARY TO ENTER OR WIN. As an additional entry, users may also fill out the digital form on www.bostoninteriors.com/sweepstakes. Entrants must complete all required steps to be eligible to enter to win a prize by midnight Monday December 10th, 2018. Incomplete, illegible, corrupted or untimely entries are void and will be disqualified. Entries must be submitted by the individual entrant. All entries become the property of **Boston Interiors** when submitted and will not be returned to entrant. The Sweepstakes begins at **10:00 am ET, December 7, 2018 and runs through 11:59 pm ET, December 10, 2018 (the “Promotion Period”)**. *The winner will have the choice to pick up the gift basket in the Boston Interiors Stoughton location or have it shipped.*

2. Limitation on Entries and Other Conditions on Entry. There is a limit of one (1) entry, per Instagram handle, per eligible person. One (1) additional entry may be made only by filling out the digital form on www.bostoninteriors.com/sweepstakes. For an entry to be considered received, it must be submitted before the end of the Promotion Period. If otherwise valid and complete multiple digital form entries are received before the end of the Promotion Period, only the first entry will be accepted, and additional entries will be disqualified. Multiple participants are not permitted to share the same social media account. Any attempt by you to obtain more than one (1) entry during the Promotion Period by using multiple/different social media accounts, identities, registrations or logins, or any other methods may void your entries and you may be disqualified from the Sweepstakes. 3. Disqualification of Certain Entries. Entries that have been tampered with or altered are void. If, in the opinion of **Boston Interiors**, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Promotion, or if computer virus, bugs, unauthorized intervention, fraud, or technical difficulties or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Promotion, **Boston Interiors** reserves the right at its sole discretion to disqualify any individual who tampers with the entry process and void any entries

5. Prize(s):

Each prize, which may consist of a gift card or merchandise, including its retail value, will be described on our Sweepstakes webpage. **Boston Interiors** reserves the right to substitute any prize with a prize of comparable value.

6. Winner Selection and Notification. One winner will be selected from among all of the valid entries received during the Promotion Period via random drawing of all eligible entries received. All decisions by **Boston Interiors** in relation to the Sweepstakes are final and binding. The drawing shall take place on or about December 12, 2018 in Stoughton, MA. The winner shall be notified via email (or social media private message) within 5 days of the drawing. The winner will have 5 days from the announcement date to acknowledge receipt of the winner notification. If the prize is not claimed within the 5-day time limit an alternate prizewinner will be drawn at random from all eligible entries received. The original prizewinner will forfeit all rights and have no further rights to any prize nor any claims against **Boston Interiors** based on the forfeiture of their winnings. 9. Odds of Winning. The odds of winning shall be determined based on the number of entries received.

10. Eligibility. The Sweepstakes is open to anyone who is a legal United States resident and who is 18 years of age and older as of the Promotion start date. The prize is personal to the selected winner and is not assignable to any other person or entity.
